2. Data retention

We must also keep your payroll records, holiday pay, sick pay and pensions auto-enrolment records for as long as is legally required by HMRC and associated national minimum wage, social security and tax legislation.

Where the Company has obtained your consent to process your personal data obtained from your CV, we will do so in line with our retention policy. Upon expiry of that period the Company will seek further consent from you. Where consent is not granted the Company will cease to process your CV.

Candidates CV will be retained for at least one year from (a) the date of their creation or (b) after the date on which we last provide you with work-finding services.

3. Your rights
